

# AllOne – Terms of Service

#### 1. Definitions

- **AllOne**: The Discord bot and accompanying web dashboard available via <a href="https://allonebot.com">https://allonebot.com</a> and <a href="https://dashboard.allonebot.com">https://dashboard.allonebot.com</a>.
- **User**: Any individual or entity that uses the AllOne bot or dashboard services.
- **Services**: The suite of tools, features, and interfaces offered by AllOne, including Discord functionalities and the web-based control panel.
- **Dashboard**: The web-based management portal allowing users to configure, monitor, and control bot functionality, permissions, integrations, and usage.

## 2. Acceptance of Terms

By accessing or using the AllOne bot or dashboard, you agree to be bound by these Terms of Service. If you do not agree with any part of these terms, you may not use our services.

AllOne reserves the right to modify these Terms at any time. Updated terms will be published on our website, and your continued use of the services after such updates constitutes acceptance of the revised terms.

  - Use the bot for unauthorized automation or data scraping.

- All actions performed through your account or server configuration are your sole responsibility.

- While AllOne aims to provide stable 24/7 uptime, we do not guarantee uninterrupted access to the bot or dashboard.
- Downtime may occur for maintenance, updates, or unforeseen issues.
- We are not responsible for any loss or damage resulting from outages, latency, or service interruptions.
- We reserve the right to suspend or revoke access to users violating these Terms.

### 5. Data Collection and Privacy

- AllOne only collects essential user data, including:
  - Discord user IDs and server IDs,
  - Discord user data, such as servers you're in, your email, name and more.
  - Configuration data,
  - Logs for error handling and performance analysis.
- Collected data is never sold or shared with third parties except where required by law.

- AllOne complies with privacy best practices and applicable data protection regulations.
